**ARTICLES OF ORGANIZATION
FOR
CAT FIVE OF PUNTA GORDA, LLC**

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of CAT FIVE OF PUNTA GORDA, LLC ("Company"), under the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

PURPOSE AND POWERS**
