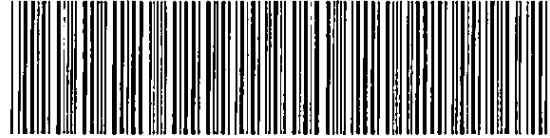

ARTICLES OF ORGANIZATION

Pursuant to the provisions of Chapter 605, Florida Statutes, as amended, the following are hereby adopted and filed as the Articles of Organization of this Florida limited liability company:

ARTICLE I - NAME

The name of this Company shall be as follows:

ARTICLE VIII - AMENDMENT

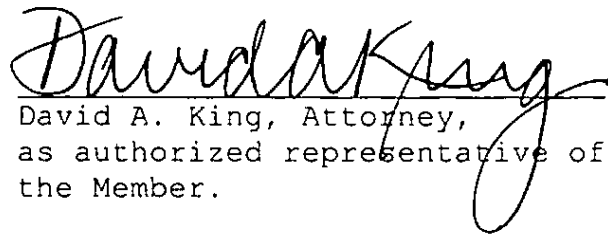

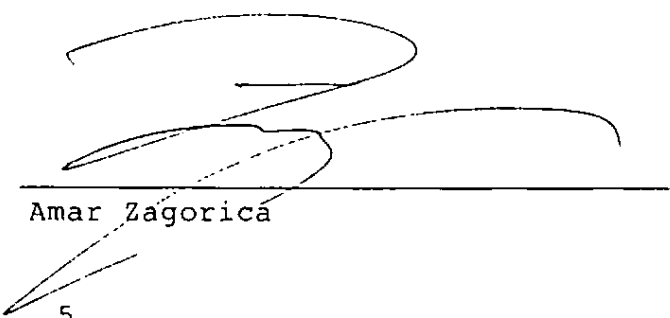
