ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

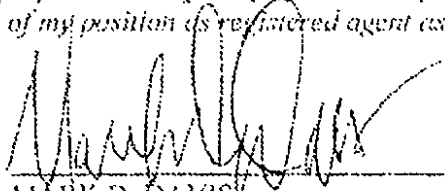
The date for commencement of the Company's existence shall be June 8, 2020. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.
