AMENDED AND RESTATED ARTICLES OF ORGANIZATION of DOYLE RENTAL PROPERTIES, LLC

The Authorized Representative on behalf of the member, hereby makes, subscribes, acknowledges and files these Amended and Restated Articles of Organization to form a limited liability company in accordance with the Florida Revised Limited Liability Company Act and other laws of the State of Florida.

ARTICLE I NAME

The name of the limited liability company shall be Doyle Rental Properties. LLC (the "Company"). The mailing and street address of the principal office of the Company shall be 5010 Buttonwood Drive, Ponte Vedra Beach, Florida 32082.
