**ARTICLES OF ORGANIZATION

The undersigned, Lino Maldonado, a natural person competent to contract and an authorized representative of BeHome Investment Group, LLC, hereby presents these Articles of Organization as the Articles of Organization of BeHome Investment Group, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I – NAME**

The name of the limited liability company is BeHome Investment Group, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

**ARTICLE II – PRINCIPAL OFFICE ADDRESS**

The street and mailing address of the Company’s initial principal office is 200 Birdsong Creek Cove, Niceville, Florida 32578.

**ARTICLE III – PURPOSE AND POWERS**
