**ARTICLES OF ORGANIZATION  
OF  
WHITE FAMILY HOLDINGS, LLC**

The undersigned, Terry J. White, a natural person competent to contract and an authorized representative of White Family Holdings, LLC, hereby presents these Articles of Organization as the Articles of Organization of White Family Holdings, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is White Family Holdings, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The street address of the Company's initial principal office is 7 Calhoun Avenue, Destin, Florida 32541. The mailing address is P.O. Box 278, Destin, Florida 32540. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.


