**ARTICLES OF ORGANIZATION
OF
SADIE S PROPERTIES, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act ("Act"), does hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is **SADIE S PROPERTIES, LLC**.

**ARTICLE II
ADDRESS**

The Company's street address of its principal place of business in Florida is 8883 Salt Grass Drive, Pensacola, FL 32526, and its mailing address is 8883 Salt Grass Drive, Pensacola, FL 32526, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members:

**ARTICLE III
MANAGEMENT**


ARTICLE VI
