The name of the limited liability company is **ISLES OF CAPRI, LLC** (hereinafter, the "Company").

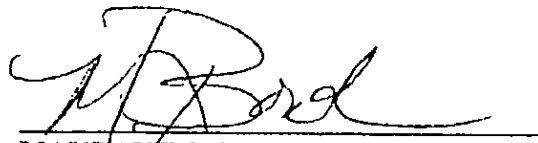
