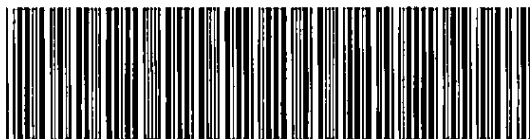

The name of the limited liability company shall be **1510 PROPERTY GROUP, LLC**.


ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND ADDRESS

income or expense by the method provided in these Regulations, and if no method is specified, then as may be permitted by Section 706(d) of the Code.


ARTICLE VII - CONTINUATION OF BUSINESS


