**ARTICLES OF DISSOLUTION

1. The name of the limited liability company is Publix Employees Federal Credit Union Benefit Plan LLC (the "Company").
2. The Articles of Organization of the Company were filed on June 16, 2020, and assigned document number L20000166810.
3. The effective date of the Company's dissolution is the date these Articles of Dissolution are filed with the Florida Department of State.
4. The dissolution of the Company was authorized by the sole member on October 29, 2021, by way of a written consent, which is the occurrence that resulted in the Company's dissolution.
