Second. The name of the surviving entity is Vimvest Merger Sub, LLC, a Florida limited liability company (the "Vimvest Merger Sub").

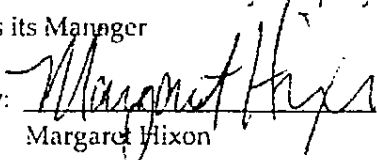

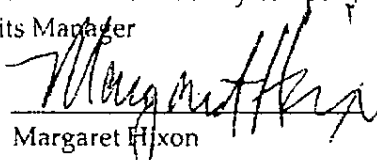

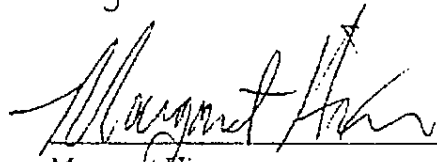
