The Limited Liability Company is to be managed by its members individually and is therefore a member managed company. The initial members shall be:



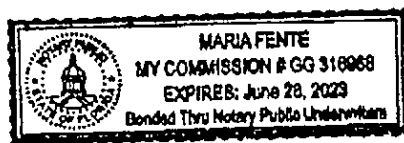

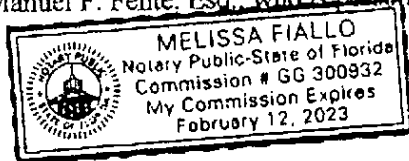
