**ARTICLE I**

Name. The name of the limited liability company shall be ENN FOODS, LLC ("Company").

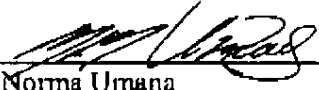

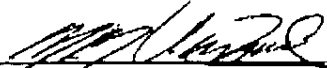
