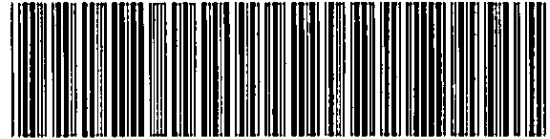

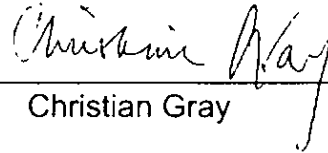
## NAME CHANGE AGREEMENT
