ARTICLES OF ORGANIZATION  
OF  
TRANSPACIFIC HOLDINGS LLC

The undersigned, being the Member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is TransPacific Holdings LLC (the "Company").
