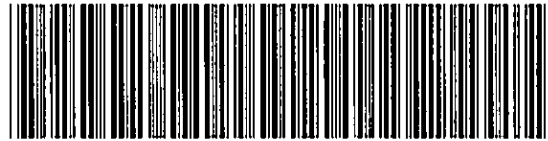



The undersigned subscriber to these Articles of Organization hereby forms a professional limited liability company under Florida Statutes Chapter 621, Professional Service Corporations and Limited Liability Companies (the "Act").

ARTICLE I – NAME

The name of the professional limited liability company shall be Mirna Hormechea, PLLC (the "Company").


ARTICLE IV – INCORPORATION OF PROVISIONS OF
PROFESSIONAL SERVICE CORPORATION ACT


