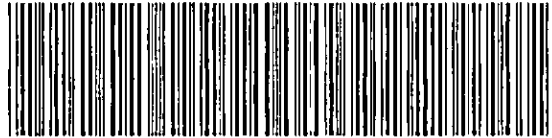

The name of the Limited Liability Company is "**DK Legacy Holdings, LLC**" (the "**Company**").


Article 2.
