The undersigned, BRITT ANNE PEAT, a natural person competent to contract and an authorized representative of Kiddie Academy of Pensacola, LLC, hereby presents these Articles of Organization as the Articles of Organization of Kiddie Academy of Pensacola, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Kiddie Academy of Pensacola, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."


