
Pursuant to the provisions of Section 605.0202, Florida Statutes, **The Shoals, LLC**, a Florida limited liability company (the "Company"), adopts the following amendment (the "Amendment") to its Articles of Organization:

1. The name of the Company is **The Shoals, LLC**.
2. The Articles of Organization were filed on July 13, 2020 and assigned document number L20000197936.
3. Article VI of the Articles of Organization of the Company is hereby amended by deleting it in its entirety and replacing it with the following:
