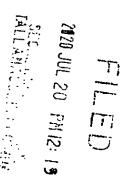

#### ARTICLES OF CONVERSION FOR FLORIDA CORPORATION INTO FLORIDA LIMITED LIABILITY COMPANY

(Pursuant to Florida Statutes §607.11933)

The Articles of Conversion and attached Articles of Organization are submitted to convert the following Florida corporation into a Florida Limited Liability Company in accordance with §607.11933, Florida Statutes.

- 6. The Converted LLC has agreed to pay any members having appraisal rights the amount to which such members are entitled under §607.1302 or §605.1006 and 605.1061-605.1072, Florida Statutes.
- 7. The principal office of the Converted LLC shall be located at 9025 N. Atlantic Avenue, Cape Canaveral, Florida 32920.
