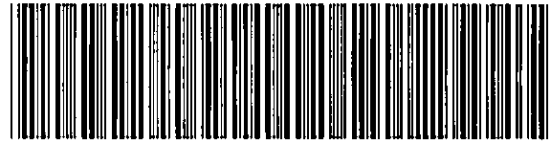

ARTICLE IV - DESCRIPTION OF OCCURRENCE


