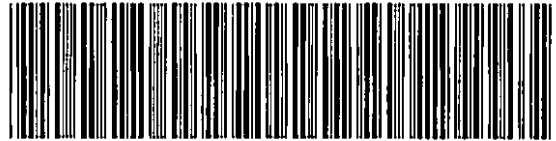

The Company's principal office and mailing address is 6487 Ashley Drive, Lakeland, Florida 33813.


**ARTICLE III.


