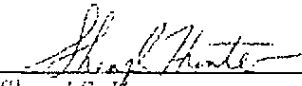

The LLC is formed for an indefinite duration.

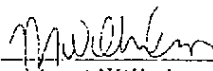

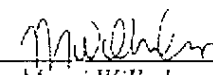
