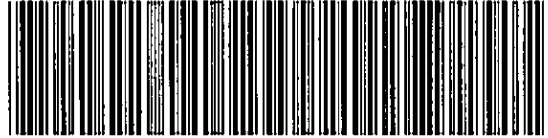



The undersigned, pursuant to the provisions of §605.0201 of the *Florida Revised Limited Liability Company Act* (the "Act"), desiring to form a limited liability company under the laws of the state of Florida, hereby adopts Articles of Organization for such limited liability company in the form set forth herein:
