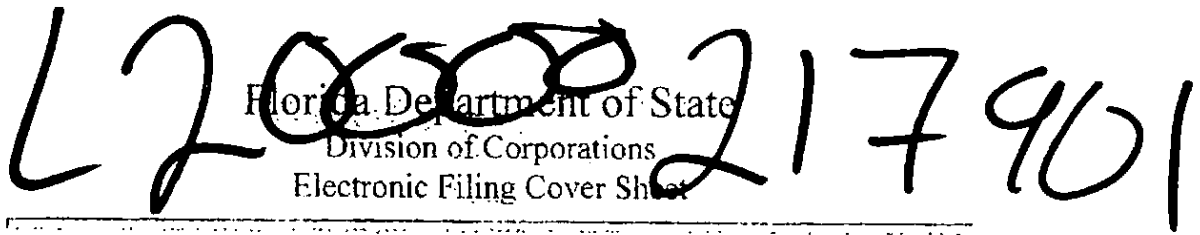

**ARTICLES OF ORGANIZATION
OF

The following articles of organization are submitted in accordance with Florida Statutes Section 605.0201:

ARTICLE I

ARTICLE V

Membership in the limited liability company shall be limited to not for profit entities that are tax exempt within the meaning of Section 501(c)(3) of the Internal Revenue Code. The limited liability company is organized exclusively for such charitable, educational and scientific purposes as (a) will qualify it for exemption from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or the corresponding section of any future United States Internal Revenue Law and (b) will qualify its income (or the income allocated to its Members) for exclusion from gross income for federal income tax purposes

pursuant to Section 115(1) of the Code, or the corresponding section of any future United States Internal Revenue Law. The limited liability company shall not carry on any activities not permitted to be carried on by (i) an organization exempt from federal income taxation under Section 501(c)(3) of the Code, or corresponding section of any future United States Internal Revenue Law, or (ii) an organization to which contributions are deductible under Section 170(c)(2) of the Code, or corresponding section of any future United States Internal Revenue Law.

ARTICLE VI

These articles of organization shall be effective upon filing.

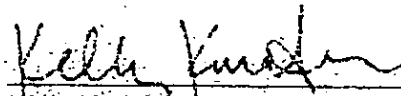
