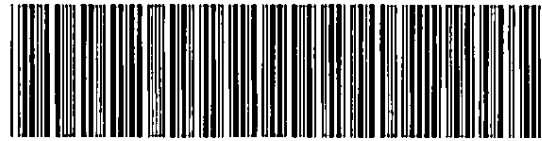

3. The name of the Florida limited liability company as set forth in the attached Articles of Organization is HARMAC INVESTMENTS, LLC.


