ARTICLE V

Management of Business

Except for rights that are specifically reserved to the members in the Operating Agreement or these Articles, management of the Company shall be vested in its manager(s). Accordingly, the Company shall be a manager-managed company. Managers shall be elected by the members holding fifty-one percent (51%) of the then outstanding membership interest of the Company. The Managers may be, but are not required to be, members of the Company. The Managers shall have the power and authority to act on behalf of the Company as provided in Chapter 605, Fla. Stat., as the same may be amended from time to time, and as further provided in the Operating Agreement of the Company.

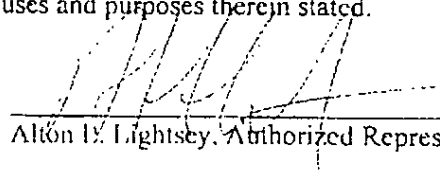

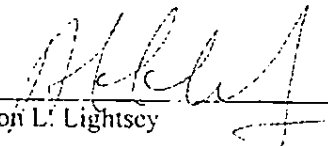
