
## ARTICLE VII NEW MEMBERS



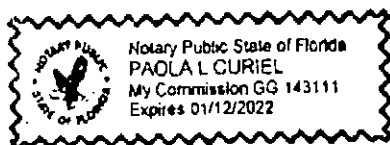
