**ARTICLES OF ORGANIZATION
FOR
D & B NY ACTIVE ZONE BUSINESS LLC**

(A Florida Limited Liability Company)

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, pursuant to the Florida Revised Limited Liability Company Act (the "Act"), hereby adopts the following Articles of Organization:

**ARTICLE 1
NAME**

The name of the Limited Liability Company is D & B NY ACTIVE ZONE BUSINESS LLC (the "Company").

**ARTICLE 2
DURATION**

The Company shall exist on the date of filing of these Articles with the Secretary of State of the State of Florida. The duration of the Company shall be perpetual.

**ARTICLE 3
NATURE OF BUSINESS**

The purpose of the Company shall be to qualify as a "qualified opportunity zone business" under Section 1400Z-2 of the Internal Revenue Code of 1986, as amended (the "Code") and to, directly or indirectly, through the Company and one or more subsidiaries, identify, source, acquire, originate, maintain, own, manage, finance, refinance, sell, hold, reposition, pledge, hypothecate, hedge, exchange, and otherwise deal with or use assets in order to conduct business as a "qualified opportunity zone business" as defined by Section 1400Z-2 of the Code. The "qualified opportunity zone business" is expected to involve the use of real estate located in the opportunity zone located in Warsaw, NY, in such a way that D & B NY Active Zone Business LLC qualifies as a "qualified opportunity zone business" under Section 1400Z-2(d) of the Code. The Company shall have the power and authority to conduct any and all activities related or incidental to the purpose of qualifying as a "qualified opportunity zone business" under Section 1400Z-2 of the Code.

**ARTICLE 4
ADDRESS**

The initial principal office address and the initial mailing address of the Company is 401 E Jackson St., Ste, 2500, Tampa, FL 33602.
