ARTICLES OF ORGANIZATION
OF
TDC GATEWAY, LLC

The undersigned, acting as the organizer of TDC GATEWAY, LLC, under the Revised Florida Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is TDC Gateway, LLC (the "Company").

ARTICLE II - Address:

ARTICLE III - Duration:

ARTICLE VII - Initial Registered Agent and Office:

The initial registered agent for the Company shall be CT Corporation System., and the street address of the Company's initial registered office is 1200 South Pine Island Road, Plantation, Florida 33324.

ARTICLE VIII - Amendments:

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated in accordance with the terms of the Operating Agreement of the Company.


ARTICLE IX – Continuation of Business:
