NAME

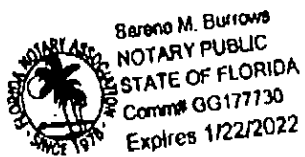




