Purpose

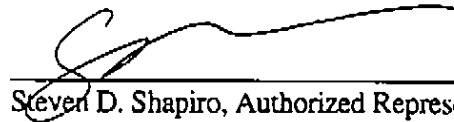

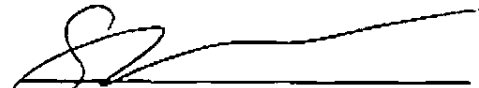
