**AMENDED AND RESTATED ARTICLES OF ORGANIZATION

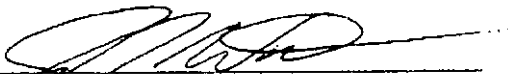
ARTICLE VI. PURPOSE
