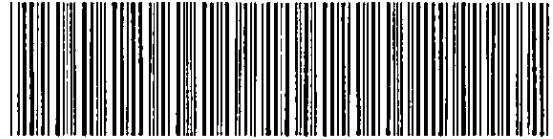

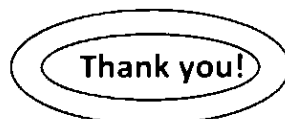

4. The effective date of the conversion is August 14, 2020.

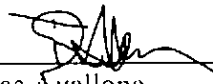

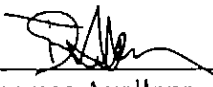
