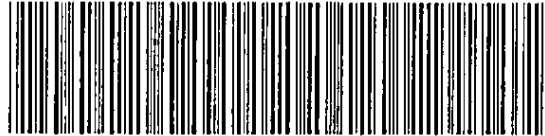

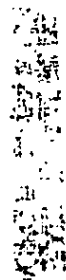


ARTICLE IX - MANAGEMENT
