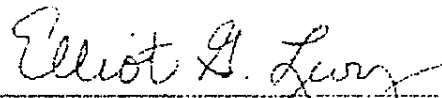
**ARTICLE IV**

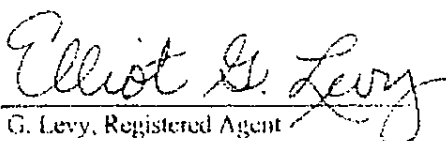
