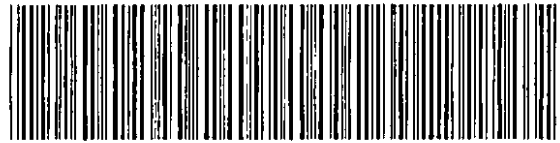




ARTICLE V - Purpose and Powers
