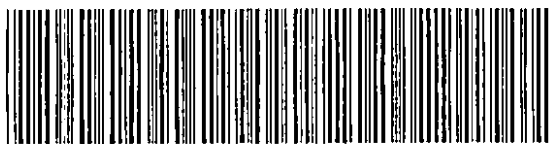


ARTICLE V – MANAGEMENT

ARTICLE VI – INITIAL MANAGER


