



# Letter of Explanation

January 15<sup>th</sup>, 2024 P.B. YS.

This letter is in response to the following: TOTAL SMOOTHIE DISTRIBUTION, LLC., January 3, 2024, ARTICLES OF DISSOLUTION filing – L20000248495.

The above-referenced request for dissolution should be rejected because the entity improperly filed for dissolution due to:

1. Knowing that I have no affiliation with the company, I am listed as “the” point of contact, appointed to wind up the company’s affairs and activities.
2. Knowing that I had not given consent, whoever filed the ARTICLES OF DISSOLUTION, listed my personal information, including name and home address.
3. The Florida Revised Limited Liability Company Act (Chapter 605, Florida Statutes) states that under this act, an LLC may not dissolve if there are still outstanding debts and obligations unless those debts and obligations are properly addressed and paid off as part of the dissolution process – knowingly they still filed the referenced ARTICLES OF DISSOLUTION.
4. Knowing that I have no affiliation with the company, they ignore requests to update and remove my status as a member.
5. The individual listed as having filed this document is not listed anywhere in the company’s previous filings as a member, particularly in the last annual report filed, therefore, he is not legally qualified to act in any capacity on behalf of TOTAL SMOOTHIE DISTRIBUTION, LLC, especially its dissolution.

Based on the foregoing, fraudulently affirming to the Florida Department of State that the information provided is correct and true, a 3<sup>rd</sup> degree felony as provided in section 817.155 Florida Statutes was committed. Therefore, this improper and illegal dissolution is in violation of your statutes and as a result, dissolution should not be granted at this time.
