**ARTICLES OF ORGANIZATION

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended, superseded or replaced ("Act").

**ARTICLE I - NAME**


**ARTICLE IV - MANAGEMENT OF THE COMPANY**


