**ARTICLES OF ORGANIZATION  
of  
O'STEEN VW, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be O'Steen VW, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 11401 Phillips Highway, Jacksonville, Florida 32256.

**ARTICLE II**

**PURPOSES AND POWERS**

## **ARTICLE VII**


### **DURATION AND COMMENCEMENT**


