We, the undersigned, hereby execute these Articles of Organization for the purpose of organizing a limited liability company under the laws of the State of Florida.

#### ARTICLE I

The name of the limited liability company is MACHER PROPERTY MANAGEMENT, LLC.

## ARTICLE II

The mailing address of the limited liability company shall be 4351 Eagle Landing Parkway, Orange Park, Florida 32065, and its street address is the same.

#### ARTICLE III
