ARTICLES OF ORGANIZATION

OF

THE UNDERSIGNED, hereby adopts the following Articles of Organization for the purpose of forming a limited liability company Pursuant to s. 605, Florida Statutes, under the law of the state of Florida.

ARTICLE 1 - Name

ARTICLE 5 - Commencement and Duration

The limited liability company is to commence its company existence effective upon filing hereof, and shall exist perpetually thereafter until dissolved according to law

ARTICLE 6 – Purpose and Powers

The limited liability company is organized for the purpose of transact any and all lawful business for which a limited liability company may be organized under the laws of the State of Florida. ARTICLE 9 - No Personal Liability

The private property of the manager or managing members shall not be subject to the payment of the limited liability company debts.

ARTICLE 10 - Indemnification

The limited liability company shall indemnify any present of former manager or managing members, or person exercising powers and duties of a manager or managing members, to the full extent now or hereafter permitted by law.
