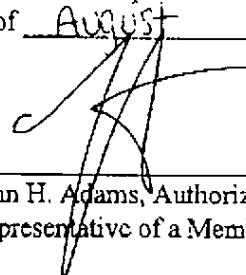
**ARTICLE VII - Additional Members**

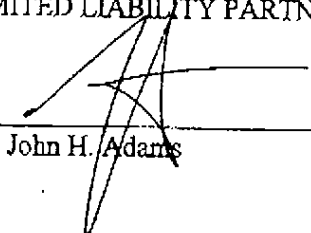
