**ARTICLES OF ORGANIZATION
OF
TRIPLET THREAT LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is Triplet Threat LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 955 NW 17th Avenue, Building J, Delray Beach, Florida 33445.

ARTICLE III. REGISTERED AGENT AND OFFICE

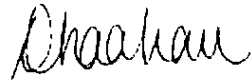
