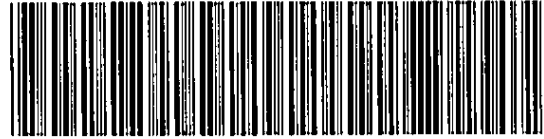


The Company shall be a manager-managed Limited Liability Company.
