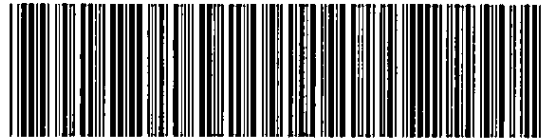

**ARTICLES OF ORGANIZATION
OF
ECOVIBE, LLC**

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Revised Limited Liability Company Act.

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is **EcoVibe, LLC** (the "Company").

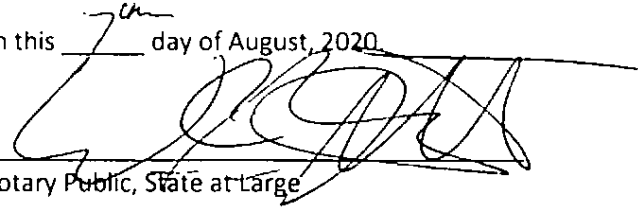

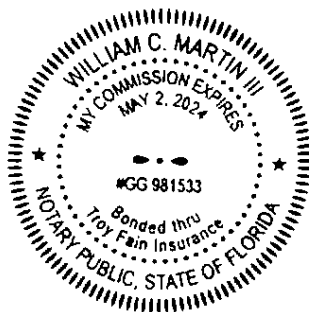

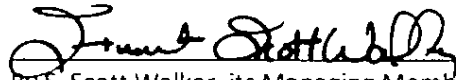
