The undersigned, being the sole member of ATIX LABS LLC, adopts the following Amended and Restated Articles of Organization pursuant to the authority and provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act:

FIRST: The name of the limited liability company filing these Amended and Restated Articles of Organization is ATIX LABS LLC (the "Company").
