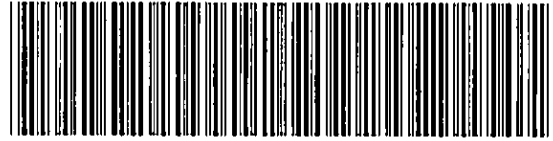

ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I. NAME**

The name of the limited liability company is PEMAM LLC (the "Company").

**ARTICLE II. ADDRESS**

The principal and mailing address office of the Company is 200 S. Biscayne Blvd., 7<sup>th</sup> Floor, Miami, FL 33131.

**ARTICLE III. REGISTERED AGENT AND OFFICE**

The Company designates 200 S. Biscayne Blvd., 7<sup>th</sup> Floor, Miami, FL 33131 as the street address of the initial registered office of the Company and names South Florida Agent Services Corporation as the Company's initial registered agent at that address to accept service of process within this state.

**ARTICLE IV. DURATION AND CONTINUATION**

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated in accordance with the Company's Operating Agreement or pursuant to the Act, as amended from time to time.

**ARTICLE V. MANAGEMENT**

The Company shall be conducted, carried on, and managed by at least one (1) Manager and is, therefore, a manager-managed Company. The names and addresses of the initial persons authorized to manage and control the Company are:

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida including activities within the United States and abroad.


**ARTICLE VII. ADDITIONAL MEMBERS**


