

**ARTICLE VII****NATURE OF BUSINESS**



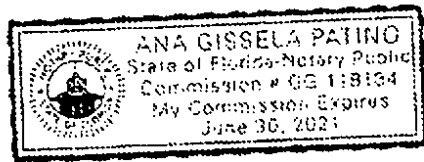


